#### Trustee induction and training

Recruitment

Recruitment of Branch Volunteers, including Committee/Trustees is carried out by internal Membership communication, Website, Facebook, local and other media. Those RAFA Branch Members wishing to serve as Committee/Trustee are required to be nominated and seconded by Members who must be Members of RAFA and the Branch. Supported nominations are put to the Annual General Meeting of the Branch which takes place in March. It should be noted that no other external individuals or organisations are permitted to appoint/nominate a Committee Member/Trustee.

All Trustees (post AGM elections) will complete an OSCR Declaration, a Branch Conflicts of Interest Declaration, in addition to signing RAFA's Form 1056 (Annual Branch Governance Return).

#### Good Governance

During the course of the year we have continued to ensure we conform to the standards and requirements of the Good Governance Award. We have reviewed and updated all our Policies to ensure we are all aware of our roles and that we uphold the standards set by these.

#### Welfare

Despite the continuing restrictions caused by the pandemic, our Welfare Officer continues to ensure that his welfare cases are undertaken in as prompt and caring manner as possible. It should be noted that welfare cases are allocated by our Area Office so a considerable number of cases are dealt with out-with the framework of the Branch, however, the important part of this is cases are dealt with and our RAF family receive the help they need. As a Branch we have dealt with several cases and have facilitated £37000 in funding for our beneficiaries'.

The latter was held after the Wings money had been returned to HQ and the money raised has been banked for the Wings Appeal 2022.

## Achievements and performance

Summary of the main achievements of the branch during the year

Through the commitment of the Honorary Welfare Officer, a creditable number of welfare cases have resulted in good outcomes for the beneficiaries. Our HWO was shortlisted for Caseworker of the Year. In addition, our HWO took the Remembrance Service in Coldingham together with his wife who laid our wreath.

3 Branch Members visited Rothbury House to view the work currently being undertaken to provide a new lease of life to Rothbury as retirement homes for veteran's and their spouses.

The Branch participated this year in RAFA's OpConnect with each Committee member contacting most of our over 60's members by telephone. This resulted in some wonderful conversations and catch ups.

Despite the restrictions of the pandemic, Branch Members together with the assistance of other Service Organisations marked 2021 Remembrance by laying 7 wreaths, one in every local constituency with the Branch boundaries and laid single Poppies on 7 RAF war graves in Dalkeith cemetery (an annual informal event).

We have continued to enhance our Branch communications via our website, our Facebook page and the email and distribution of approximately 2000 quarterly Branch Newsletters annually.

We sent Christmas Cards and Gift Vouchers to RAF veteran residents of Whitefoord House. Whitefoord House being where we held our face to face meetings pre COVID19.



Our Wings Appeal Officer has been providing talks virtually to several of the ATC Units within our boundaries. In addition, Our Wings Appeal Officer and Honorary Welfare Officer, as a result of a recent Partnership with 603 RAuxAF Squadron made a presentation to all in 603 which was received with great interest. On September's 2021 Battle of Britain Day, our WAO organised a successful Wings collection on a lovely sunny day in St Andrew Square, Edinburgh.

We have sent cards to our Members who have celebrated their 100<sup>th</sup> Birthdays.

We have welcomed a new Standard Bearer whom we trust will carry the Standard on all occasions going forward.

Unfortunately, and again due to the pandemic, we had to postpone our 90<sup>th</sup> Anniversary celebrations, however, these are now in place for April this year.

Congratulations to our Branch Life President has been awarded the role and title of President of 869 RAFAC Squadron in Penicuik.

We have successfully continued to hold our Monthly meetings via Zoom and we hope to be able to commence face to face meetings in the not too distant future.

## Brief statement of the branch's policy on reserves

The invested money and General Account balance as of the beginning of the 2022 financial year leaves usable funds to be utilized by both General and Welfare accounts for the remainder of 2022 with reserve funds sufficient to sustain the Branch for a minimum period of three years.

An "operational difference" between Income & Expenditure in 2021shows minus £546.06. This in the Trustees view evidences an efficient and effective use of charity funds through the year; therefore, the Trustees do not deem this difference to be a "deficit" as such.

It should be noted that the Branch's efforts in providing a welfare delivery service resulted in spend of £715.00 from Branch "Restricted Funds".

It should be noted that 2021 saw the majority of Welfare RAFA allocation being controlled centrally, however, we have actively attracted a total of



circa £37000 in grants for RAF Family beneficiaries which have already been disbursed to the benefit of those in need.
